DOG HOUSE RULES (OUR POLICIES)

The safety of your fur kid and our staff are of utmost importance to us at Just Fur Kids Dog Daycare[®]. The Dog House Rules below are in place to protect the fur kids, the humans, and the premises so that everyone can have a safe and enjoyable experience.

Medical Eligibility:

- 1. Minimum of sixteen (16) weeks of age to begin daycare. Must have all three sets of puppy vaccines.
- 2. After six (6) months of age, must be spayed/neutered to continue attending daycare.
- 3. Core vaccinations (rabies and DHPP/DAPP) must be current, and must not have been ill with any communicable illness/condition in the last 30 days.
- 4. External parasite protection against fleas/ticks/lice etc is mandatory all year round, and regular de-worming medication is recommended.
- 5. Must be certified to be of good health to participate in daily activities which will include but not limited to, outings, structured walks, treadmill, and general play.

Showing Up At Daycare:

- 1. Fur kids must be on leash when entering and exiting the facility, no exceptions no matter how well behaved. We are adjacent to a busy parking lot and a children's learning centre.
- 2. Fur kids must have their municipal dog license tag on their collar. We are legally unable to take fur kids out for potty breaks or walks without their tags. (The only exception being dogs residing in municipalities not requiring the licensing)
- 3. Fur kid belongings may look alike. Ensure their leash, collar, boots, coats, etc are all labeled for correct identification and return. We are not responsible for lost/damaged items.
- 4. If a fur kid is bringing in a midday snack and/or medication, ensure it is clearly labeled with their name and applicable instructions. Re-usable containers will all be returned. Please refrain from using glass containers for safety reasons. Feeding bowls are provided.
- 5. Fur kids should pee/poop before arriving at daycare so they are comfortable when joining their friends and not anxious about having an accident.
- 6. Just Fur Kids Dog Daycare® is a no bark, no bite, no bullying facility. Fur kids who consistently are unable to abide by these rules will be asked to leave the pack.

Other Fur Parent Responsibilities:

1. If there are any special circumstances to bring to our attention, please make sure it is done before/at the time of check in (ie: upset tummy, a paw being favored, a new allergy, etc). If it is a circumstance that greatly affects your fur kid's ability to participate in the day, you may be asked to keep them home.

- 2. In order to check in with a prepaid pass, the uniquely coded key tag issued during purchase must be present for scanning. Lost/replacement key tags are \$1.95.
- 3. Daycare attendance is on a prepaid basis. We will not put charges "on account". Cash, debit, Visa and MasterCard are the accepted forms of payment.
- 4. Minimal attendance of two days per week is recommended to ensure the continuity of experience for most fur kids. Sporadic attendance is like being the new kid every time and is stressful to all, and not encouraged.
- 5. Drop offs/pick ups are by the Primary Owner of the fur kid and/or authorized alternate only. We reserve the right to seek confirmation at the time, should this not be the case.
- 6. To maintain the schedule and energy of the pack, drop off time is to be between 6:30am and 9:00am only, no later.
- 7. Pick up is to be by 6:30pm. If you are delayed, please call us beforehand. Late pick ups are subject to a penalty fee of \$10 if before 6:45pm, \$20 if between 6:45pm & 7pm, and \$30 after 7pm. Fur kids not picked up by 7:30pm will be charged \$50 for overnight care.
- 8. During drop offs/pick ups, fur parents are not permitted beyond the lobby area. You are invited to observe at the paw window, provided you do not tap the glass or otherwise attempt to get the attention of the fur kids inside.
- 9. The rule of "no talk, no touch, no eye contact" is to be observed with all fur kids in the lobby during drop offs/pick ups in order to maintain our calm and balanced atmosphere.
- 10. Daycare reservation requests made via email, text, and/or social media are only deemed booked when Just Fur Kids Dog Daycare® sends a confirmation reply.
- 11. Daycare reservation cancellations need a minimum of 12 hour advance notification. No shows or insufficient cancellation notices are subject to a handling fee.
- 12. FURever Passes are non-transferrable, non-refundable, and have an expiry of one year from date of purchase. In the unfortunate circumstance of a fur kid reaching Rainbow Bridge, the remaining pass value can be donated to a charitable organization of your choice.
- 13. Family discount of 25% off is available for the additional fur kids of the same legal fur parent when purchasing FURever Passes. Individual passes are necessary per fur kid.
- 14. Parking for fur kid drop off/pick up must be in the spots marked for Just Fur Kids Dog Daycare® only. All spaces in the lot are reserved parking for neighboring tenants and cannot be used for any duration of time. Parking in the laneway is strictly prohibited and all parking strictly enforced by the property landlord. See diagram on front door & in lobby.
- 15. The green space surrounding the facility is shared with young children. Peeing and/or marking are **not** permitted on <u>any</u> of the property's grass areas, including immediately outside the entrance. You must pick up immediately if your fur kid poops. We have bags and a garbage just inside the lobby for your convenience. Please let us know if your fur kid pees on the cement areas so we can clean it up.

OWNER AGREEMENT & WAIVER

- 1. I am the primary licensed owner of the fur kid named and described above who seeks to be enrolled in the Just Fur Kids Dog Daycare®.
- 2. I understand my fur kid is entering a facility with other fur kids present, and that the potential exposure to disease and parasites does exist. While Just Fur Kids Dog Daycare® follows strict sanitation practices and vaccination requirements, the risk of contagious disease is always present. I agree to hold Just Fur Kids Dog Daycare® harmless of any expenses associated with medical care for my fur kid for diseases that may or may not have been contracted while attending daycare.
- 3. I warrant that my fur kid is of good health, is current on vaccinations, particularly, but not limited to, rabies, and has not been ill with any communicable condition in the past 30 days. I further warrant that I will promptly notify Just Fur Kids Dog Daycare® of any change in my fur kid's health and/or behavior, and understand that my fur kid will not be permitted to return to daycare following an illness and/or communicable condition without a veterinarian clearance.
- 4. I further understand that Just Fur Kids Dog Daycare® has relied on my representation that my fur kid is of good health, and that any/all pre-existing medical conditions which may affect their daycare experience have been disclosed prior to registration so that the necessary precautions for safety and comfort will be taken.
 - a) All fur kids will participate in the activities of the daycare at levels deemed appropriate by Just Fur Kids Dog Daycare[®]. I understand that written notice is necessary should I desire my fur kid to be excluded from any daycare activity.
 - b) Just Fur Kids Dog Daycare® reserves the right to refuse daycare admittance to fur kids whose comfort and safety is deemed to not be enhanced by the daycare experience.
- 5. I understand and agree that I am, and will remain responsible for the actions of my fur kid at all times, and hereby agree to indemnify and hold harmless Just Fur Kids Dog Daycare of any and all claims of injury, expense, costs, or damages caused by the actions of my fur kid while in their care. I warrant that my fur kid has not harmed nor demonstrated aggressive or threatening behavior towards another fur kid or human. If such behavior occurs, I understand my fur kid may be asked to leave daycare. I will also be solely responsible for all expenses incurred as a result of any/all actions of my fur kid.
- 6. I understand that during fur kid interaction and play that cuts, bites, scratches, and other injuries may occur even under careful supervision. I accept this risk and agree to solely be responsible for any/all medical costs resulting.
